

End-User License Agreement for MARUI-PlugIn v3

This End-User License Agreement ("EULA") is a legal agreement between you and KabushikiKaisha MARUI-Plugin (inc.), Hankyu Five Annex Building 11F, 1-12 Kakuta-cho, Kita-ku, Osaka, 530-0017 Japan (hereinafter "KK MARUI-PLUGIN") for the MARUI plug-in for Autodesk Maya software product version 3, including computer software, associated media, and online or electronic documentation (hereinafter "SOFTWARE PRODUCT").

The agreement is facilitated through the subscription service provided by PayPal Pte. Ltd. (hereinafter "PAYPAL").

By entering the PAYPAL subscription agreement, installing, or otherwise using the SOFTWARE PRODUCT, you accept all the terms and conditions of this EULA.

If you do not agree to the terms of this EULA, do not accept the PAYPAL subscription agreement, and do not install or use the SOFTWARE PRODUCT.

KK MARUI-PLUGIN grants you a non-exclusive, non-transferable, revocable, limited license to use the SOFTWARE PRODUCT strictly in accordance with the terms of this EULA.

1. GRANT OF LICENSE.

This EULA grants you the following rights:

Installation and Use.

You may install and use the SOFTWARE PRODUCT on any single computer.

You may use the SOFTWARE PRODUCT as a tool to create or develop your own products.

Reproduction and Distribution.

You may not reproduce or distribute the SOFTWARE PRODUCT without being expressly permitted by KK MARUI-PLUGIN.

Copies of the SOFTWARE PRODUCT may not be distributed as a part of your own product.

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

Limitations on reverse engineering and modification.

You may not reverse engineer, decompile, disassemble, or modify the SOFTWARE PRODUCT, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

Transfer.

You may not transfer your rights under this EULA to a third party.

Mandatory Activation.

The SOFTWARE PRODUCT contains measures to prevent unlicensed use.

You may not be able to exercise your rights to the SOFTWARE PRODUCT under this EULA unless you activate your copy of the SOFTWARE PRODUCT in the manner described during the start-up sequence.

Activation does require a unique user identification number ("UUID") and the user name provided to you through the PAYPAL subscription service to be sent to and stored at KK MARUI-PLUGIN.

The UUID is generated to uniquely identify the computer hardware on which you are using the SOFTWARE PRODUCT, but does not provide any information about the computer or your data. The SOFTWARE requires renewal of the activation procedure every time the subscription period expires or is renewed.

If you are not using a licensed copy of the SOFTWARE PRODUCT or if your subscription expired, you are not allowed to use the software or future software updates.

Payment terms and cancellation of subscription.

Payment is to be executed through the PAYPAL subscription service. You must comply with the payment terms set forth in the PAYPAL subscription service for the SOFTWARE PRODUCT. Automatic renewal of the PAYPAL subscription may occur unless canceled, based on the PAYPAL subscription agreement.

You may at any time cancel the PAYPAL subscription for the SOFTWARE PRODUCT. The rights and limitations set forth in this EULA remain effective until the end of the subscription period as determined by PAYPAL, upon which your rights to the SOFTWARE PRODUCT expire and you must cease use of the SOFTWARE PRODUCT and destroy all copies of the SOFTWARE PRODUCT and all of its component parts.

Termination.

Without prejudice to any other rights, GK MARUI PLUGIN may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the SOFTWARE PRODUCT and all of its component parts.

If this EULA is not renewed and paid for by you through the PAYPAL subscription service prior to the subscription expiration date, the EULA will terminate automatically,

Expiration of rights.

Your rights to the SOFTWARE PRODUCT set forth in this EULA shall automatically expire if at any time you (a) are no longer employed by the subscriber of the SOFTWARE PRODUCT; or (b) are no longer the assigned user of a licensed copy of the SOFTWARE PRODUCT with a valid current subscription; or (c) fail to renew and pay the subscription before the end of the subscription period. In either such event, you must cease use of the SOFTWARE PRODUCT and destroy all copies of the SOFTWARE PRODUCT and all of its component parts.

3. COPYRIGHT.

All copyrights to the SOFTWARE PRODUCT (including but not limited to any images, libraries, and texts incorporated into the SOFTWARE PRODUCT), and any copies of the SOFTWARE PRODUCT are owned by KK MARUI-PLUGIN. The SOFTWARE PRODUCT is protected by copyright laws and international treaty provisions. You have the right use all functions in the SOFTWARE PRODUCT as a tool to create new products and distribute them.

4. DATA COLLECTION

You agree that KK MARUI-PLUGIN may collect anonymous usage data of your use of the SOFTWARE PRODUCT including time, frequency, and duration of use, features of the SOFTWARE PRODUCT used, and errors that occur in the SOFTWARE PRODUCT during use. KK MARUI-PLUGIN does not collect any information related to your identity, the content of your work, or details about your work.

LIMITED WARRANTY.

KK MARUI-PLUGIN expressly disclaims any warranty for the SOFTWARE PRODUCT. The SOFTWARE PRODUCT and any related documentation is provided "as is" without warranty of any kind, either

express or implied, including, without limitation, the implied warranties or merchantability, fitness for a particular purpose, or noninfringement. The entire risk arising out of use or performance of the SOFTWARE PRODUCT remains with you.

LIMITATION OF LIABILITIES.

In no event shall KK MARUI-PLUGIN be liable for any special, consequential, incidental or indirect damages whatsoever (including, without limitation, damages for loss of business profits, business interruption, loss of business information, or any other pecuniary loss) arising out of the use of or inability to use this product, even if KK MARUI-PLUGIN is aware of the possibility of such damages and known defects.
